



## General conditions of use of the data

It is understood that by using the badge to access the PAYSALIA and ROCALIA events, the facilities, events and activity areas, you have accepted the following terms and conditions:

As a visitor, I acknowledge and accept that I may be photographed, filmed or recorded during **the PAYSALIA and ROCALIA** Trade Shows. I authorize the organiser and/or the organisations that cooperate with the organiser to use any text, images and sounds captured, recorded or taken at this event, which include all or part of my name, my voice and/or my person, for promotional or commercial purposes, using any medium and any means of communication that exist currently or will exist in the future (including printed material, the press, television, the Internet, mobile phones, etc.), anywhere in the world. I also acknowledge and accept that I will not have the right to any remuneration in the event of such use. If I prefer not to be filmed or photographed, I will communicate my unwillingness to the film crew or the photographer on site.

In accordance with the amended Law No. 78-17 dated 6 January 1978 and the Regulation (EU) 2016/679 dated 27 April 2016, GL events Exhibitions, controller, informs the visitor any personal data shall be processed primarily for the following purposes: the registration and the participation to **PAYSALIA and ROCALIA events**, the sending of newsletters about GL events exhibitions' events or about partners if appropriate.

The recipients of the personal data are only the relevant GL events Exhibitions departments and its partners if you accepted it.

GL events Exhibitions shall only keep personal data for such time as is necessary for the operations for which it was collected. Furthermore, the data is temporary kept for entertainment and prospection purposes, in compliance with the regulations in force.

The visitor has the right to access, modify and delete any data concerning its person. He has the right to restrict processing of its data, the right to portability of its data as well as the right to set general and specific guidelines concerning how they want their rights to be exercised after its death.

The visitor is also hereby notified that he has the right to oppose the fact that its personal data could be used for commercial prospection purposes as well as the right to oppose, due to its specific situation, any processing based on the execution of a mission of public interest or on purposes of legitimate interests.

The visitor may exercise the above-mentioned rights by sending an email to **dpglex@gl-events.com** mentionning its name, first name and provide the email address to which the answer is to be sent.

The visitor could also have the right to lodge a complaint with a supervisory authority or CNIL.

The data collected here is required in order to send the documents that will make the visit to **PAYSALIA and ROCALIA events** easier, and which include badges, access codes, useful information and invitations for the next edition of the trade shows. The visitor will be able to unsubscribe at any time if you no longer wish to receive our message.

The organiser makes a « Badge Scan » service available to visitors, allowing them to easily share their coordinates with exhibitors equipped with this system.

The visitor is expressly informed and, as such, is deemed to expressly accept that a part of its personal data (corporate name, last name, first name, mailing adress, email, phone and mobil number) will be shared with the exhibitor for which one the « Badge Scan » service has been used by the visitor, notwithstanding the fact that the visitor had, at the time of registration or preregistration, refused to share its personal data with partners.
